This court, while granting bail to the petitioners, imposed a condition that the petitioners shall report before the Inspector General of Police, Idol Wing CID, Thiruchirapalli, daily at 10.30.a.m. and 5.30.p.m. until further orders. The present petition has been filed for relaxation of the said condition.

3. Heard both sides.

4. The learned Government Advocate (Crl.) on instruction submitted that the petitioners complied the conditioning imposed by

this Court. Hence, the condition imposed on the petitioners in Crl.O.P.Nos.11782 and 11783 of 2018 dated 01.08.2018 is modified to the effect that the petitioners are directed to report before the Inspector General of Police, Idol Wing CID, Thiruchirapalli once in a week, i.e., **every Monday at 10.30.a.m. until further orders.**
