This petition has been filed to relax the condition imposed on the petitioner in Crl.M.P.No.14700 of 2017 in Crl.A.No.743 of 2017 dated 23.11.2017 against the C.C.No.13 of 2013 directing the petitioner to appear before the trial Court on the first working day of every English Calendar month at 10.30 a.m until further orders.

2. The learned counsel for the petitioner as well as the learned Additional Public Prosecutor would submit that from the date of suspension of sentence the petitioner is regularly complying with the condition imposed by this Court.

3. Taking into consideration of the submissions made by the counsels on either side, the condition imposed on the petitioner in Crl.M.P.No.14700 of 2017 in Crl.A.No.743 of 2017 dated 23.11.2017

is modified. However, the petitioner shall appear before the trial Court on the first working day of alternative months commencing from November 2018.
