Original Petition praying that this Hon'ble Court may be pleased to approve the scheme framed by the petitioner trust in paragraph 10 to 12 to lease the property namely New Door No.127/1, and New Door No.1 (Old No.127 and Old Door No.1), Plot No.7 and 1, T.T.K.Road, Demonte Colony, Alwarpet, Chennai 600 018 in extent 4.59 grounds (11,016 sq.ft.,) bounded on the North by : Road from T.T.K.Road, South by Road and Door No.2, East by land in S.No.3709/3 and 4, West by TTK Road, more fully described in the schedule hereunder, as per the aims and objects and the purpose for which the Trust was created and as per the order passed by the Supreme Court dated 14.12.2011 in Civil Appeal bearing No. 3052/2006, by

a) Calling for public offers by placing advertisement in Newspaper;

b) to scrutinize the offers in consultation with the consultant appointed by the petitioner and select the most advantageous offer, in the best comprehensive



interest of the petitioner.

c) to execute registered lease deed with the prospective lessee.

That the Original Petition No. 819 of 2018 be and is hereby dismissed as withdrawn.
