Therefore, without expressing any view on the merits of the claim made by the petitioner, the writ petition is disposed of only by directing the second respondent to dispose of the petitioner's representation dated 07.11.2016 and pass orders on the same on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order, after hearing all the parties concerned.
