ORDER

4. Today, an Affidavit dated 20.02.2018 was also filed by the 2nd respondent/defacto complainant to the effect that he has no objection to quash the proceedings in D.V.No.3 of 2013 pending on the file of the learned Judicial Magistrate, Tambaram.

5. Recording the same, the proceedings in D.V.No.3 of 2013 pending on the file of the learned Judicial Magistrate, Tambaram, is quashed. The Criminal Original Petition is allowed. Consequently, the connected Miscellaneous Petitions are closed.
