This petition is filed to withdraw H.M.O.P.No.33 of 2018 on the file of Sub Court, Sathyamangalam, Erode and transfer the same to the file of Principal Family Court, Coimbatore.

2.When this petition is taken up for hearing, Ms.M.Indira Priyadarshini, learned counsel representing Mr.N.Manokaran, learned counsel for the respondent submitted that the respondent has no objection to transfer H.M.O.P.No.33 of 2018 pending on the file of Sub Court, Sathyamangalam, Erode to the file of Principal Family Court, Coimbatore and she has also made an endorsement to that effect.

5. Accordingly, the Transfer Civil Miscellaneous Petition is ordered. No costs. Consequently, connected Miscellaneous Petition is closed.
