COMMON ORDER

These four writ petitions are filed by the petitioner herein seeking a Writ of Certiorari, calling for the records in charge sheet No.8, 9, 10 & 11/2015 dated 26.06.2015, from the second respondent namely Superintendent of Police, CBI, Economic Offences-I, CBI Head Quarters, New Delhi, with a prayer to quash the same.

2 Notices were ordered and interim stay was granted by this Court in the above writ petitions on 28.08.2015.

3 After receipt of the notice, the second respondent has filed a detailed counter on 05.07.2016, raising preliminary objection regarding the jurisdiction of this Court stating that the alleged crime is the subject matter of trial before the Special Judge, Rohini, Delhi. Besides on facts also, the prayer has been opposed by the second respondent.

4 Now, when the matter is taken up for final hearing, the learned counsel for the petitioner seeks leave of this Court to withdraw these writ petitions. The petitioner has sought for the said relief without adverting to the merits of the petitions.
