Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus calling for the records of the second respondent in his proceedings vide memo No.1063/adm.1/A.4/F.Doc/2013 dated 11.02.2013 for the petitioner's removal of service from the post of Wireman, Kozhipakkam, from the service of the 5th respondent with immediate effect and quash the same and direct the second

respondent to reinstate the petitioner as a Wireman with all appropriate back wages and benefits and to direct to pay subsistence allowance till such reinstatement.
