The petitioner seeks for mandamus directing the second respondent to consider his representation dated 03.11.2017, wherein and whereby, he sought for issuance of Patta in his favour in respect of Survey No.21/1, measuring to an extent of 1 Acre 25 cents situated at Vatharapalli (Revenue Village), Ganagonda Palli Firka, Baligonapalli (Post), Hosur (Tk), Krishnagiri District.

4. The grievance of the petitioner before this Court is that the said representation has not been considered so far. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the second respondent to consider and decide the same on merits and in accordance with law. Accordingly, this writ petition is disposed of, only by directing the second respondent to consider the representation of the petitioner dated 03.11.2017 and pass orders on the same on merits and in accordance with law, after hearing rival claimants, if any. Such exercise shall be done by the second respondent within a period of eight weeks from the date of receipt of a copy of this order. No costs.
