4. The plaintiff appears as party-in-person. Hence refund of court fee be issued in the name of the plaintiff and the same shall be identified by the counsel for the defendant namely L.J.Vengatesh.

This Lok Adalat award is passed in terms of the above settlement.

The full Court fee paid shall be refunded to the plaintiff in the manner provided under Section 69-A of the Tamil Nadu Court-Fees and Suits Valuation Act, 1955 and the Court Fees Act, 1870 as

provided for under sub Sec.1 of Section 21 r/w 25 of LSA Act 1987 as amended in 1994.
