The Original Application No.5666 of 2002 was filed before the Tamil Nadu Administrative Tribunal praying to call for the records of the 4th respondent issued in Proceedings in KDIS No.138/2002-03 dated 10.07.2002 and quash the same and issue a direction to the respondents to fix the applicant's pay in the special grade scale of pay at Rs.1760/- after adding one increment at the rate of Rs.60/- in the scale of pay of Rs.1640/--2900 and fix his pay at Rs.2000 as on 01.01.1996 in the pre-revised scale and fix the corresponding pay at Rs.6300/- with effect from 01.01.1996 in the scale of Rs.5900/--200-9900 and to grant the arrears of pay and calculate the last drawn emoluments consequently for the purpose of pension. On abolition of the Tribunal, the same was transferred to the file of this Court and renumbered as W.P.No.11783 of 2002.
