if the warrant is stayed the petitioner would take steps to appear before the concerned Court.

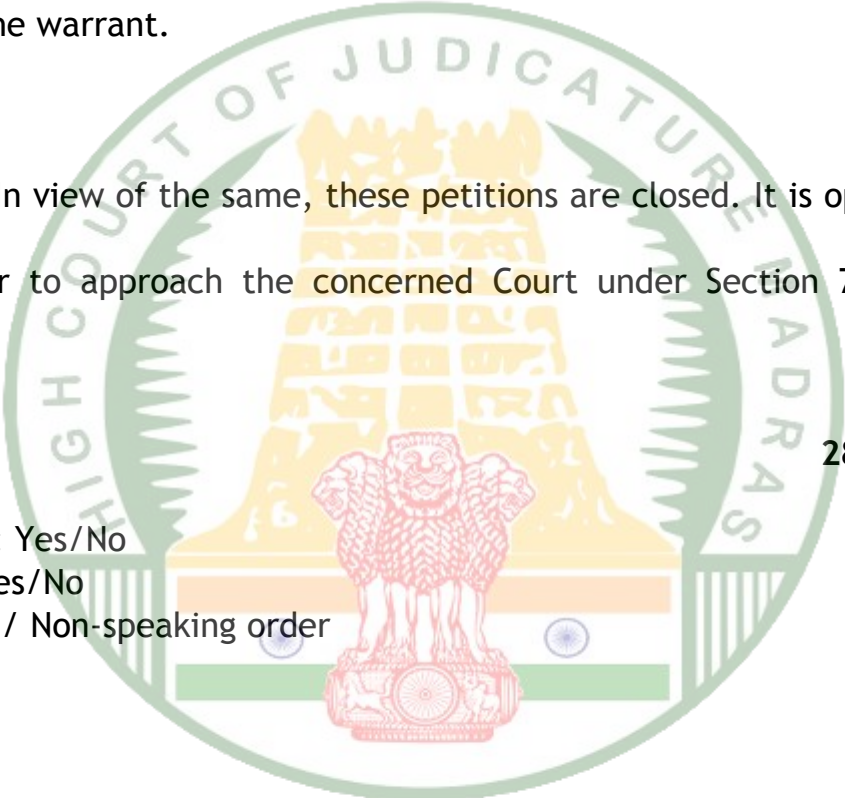
5. The provisions under Section 482 Cr.P.C. Cannot be invoked for staying the warrant.

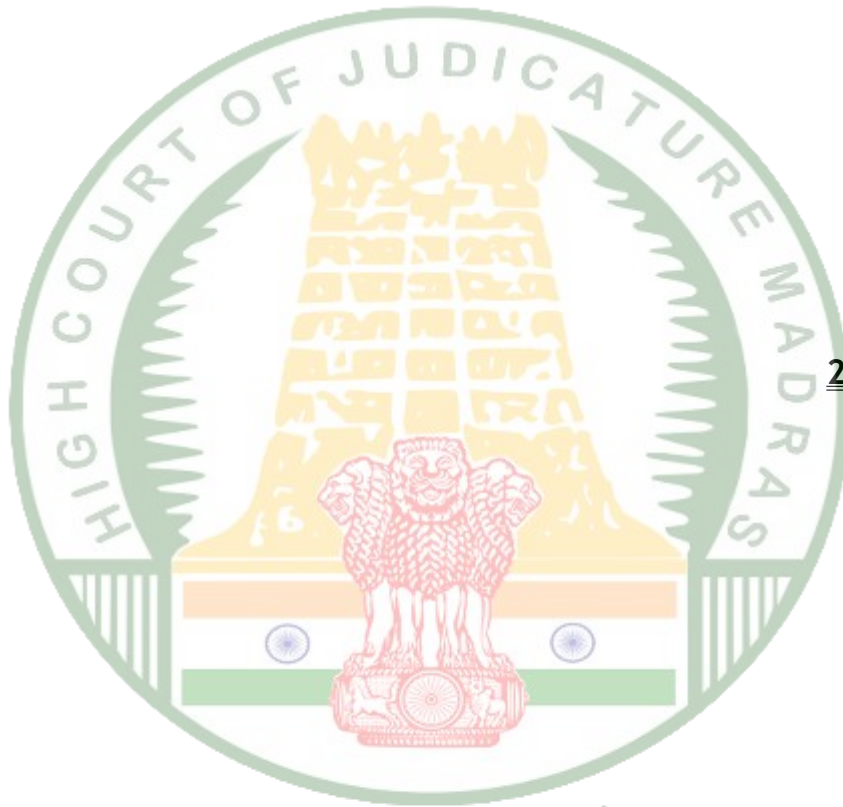
