The grievance of the petitioner is that there is no significant progress in the investigation and hence has sought for transfer the case in Crime No.85 of 2016 on the file of the C-3, Manimangalam Police Station, Sriperumpudur Taluk, Kancheepuram to District Crime Branch, I am of the view that the

ends of justice would be met if respondent be directed to conduct the investigation under the supervision of his Superior Officer. Such an investigation shall be monitored by the Deputy Superintendent of Police, Sriperumpudur on day to day basis.
