Order : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.M.DEVARAJ, Advocate for the petitioner and of MRS.A.SRIJAYANTHI, Special Government Pleader on behalf of the 1st Respondent and of MR.ANANDHA RANGAN, Advocate for the 2 & 3 Respondents and of MR.G.BALA FOR M/S.BALA & DAISY, Advocate for the 4th Respondent the court made the following order:-

The present miscellaneous petition has been filed seeking an order of interim injunction restraining the official respondents from granting promotion to the post of Assistant Sports Officer to the 4th respondent.

2. However, this Court is of an opinion that the interim injunction prayed for cannot be granted at this stage and it is made clear that all promotions made to the post of Assistant Sports Officer would be subject to the result of the final orders to be passed in this writ petition.

3. Accordingly, the Injunction petition stands disposed of. Post along with WP.Nos.7045 & 7548 of 2016 'for final disposal'.
