O R D E R

The petitioner has come forward with this writ petition, to quash the impugned order of first respondent in his proceedings No.Na.Ka.E1/8294/2005, dated 17.12.2007 by calling for all the connected records pertaining to the same and by directing the first respondent to pass a fresh orders in Na.Ka.E1/82/02 and

Na.Ka.E1/6294/05 after obtaining documents through the office of the second respondent in pursuant to disposal of W.P.35296/2007, in the interest of justice.
