While that being so, it would not be appropriate for this Court to grant a direction to conduct preliminary enquiry for the purpose of registration of the earlier complaint dated 14.04.2017. If at all the petitioner is aggrieved by the closure report, it is always open to the petitioner to challenge the closure report in a manner of law.

With the above observations, the Criminal Original Petition stands dismissed. In view of the order passed in Criminal Original petition, the connected Miscellaneous Petition is also closed.
