Prayer:- Writ Appeal filed under Clause 15 of Letter Patent Act, to set aside the order passed by this Court in W.P.No.38111 of 2005 dated 07.06.2011

W.P.No.38111 of 2005 (O.A.NO.7870 OF 2000):

O.A.NO.7870 of 2000 has been preferred before the Tamil Nadu Administrative Tribunal and on transfer to this court remembered as WP. No.38111 of 2005 praying to issue a writ of Certiorarified mandamus to call for the records in connection with the files related to the applicant regarding the proceedings issued in Lr.No. O.Mu. (Pa.AA.4) 21001/99 dated 3.1.2000 by the collector, Vellore (not communicated to the applicant) and the proceedings issued in O.Mu. (A1)/5948/99 dated 18.1.2000 by the Commissioner, panchyat Union, Thimiri and set aside the same and subsequently to direct the respondents to regularise the services of the applicant from the date of her first appointment (i.e) 14.12.1961 as Maternity Asst. and bring her in to time scale of pay and issue pensionary and other

*benefits attached to the post of regularly appointed maternity assistant.*

JUDGMENT
