ORDER

2.The petitioner has come up with this writ petition seeking a direction to the 1st respondent to consider their representation dated 28.06.2018 and pass necessary orders on merits within a time frame.



3. According to the learned counsel for the petitioner, the petitioner has submitted a representation dated 28.06.2018 seeking payment for usage of power generated from windmill, but, the same is yet to be disposed of by the respondents. Hence, the petitioner is before this Court.

4. Mr. S.K. Rameshwar, learned Standing Counsel taking notice for the respondents, submitted that the first respondent be directed to consider the petitioner's representation and pass orders in accordance with law.

5. Considering the facts and circumstances of the case and having regard to the submissions made by the learned counsel on either side, this Court directs the first respondent to consider the petitioner's representation dated 28.06.2018 and pass appropriate orders, on merits and in accordance with law, after affording due opportunity of hearing to the petitioner as well as any of the interested parties, within a period of six weeks from the date of receipt of a copy of this order.

6. Accordingly, this writ petition stands disposed of. No costs.
