ORDER

5.Considering the facts and circumstances of the case and having regard to the submissions made by the learned counsel on either side, this Court directs the 3rd respondent to consider the petitioner's representation dated 10.08.2018 and pass appropriate orders, on merits and in accordance with law, after affording due opportunity of hearing to the petitioner as well as any of the interested parties, within a period of six weeks from the date of receipt of a copy of this order.

6.Accordingly, this writ petition stands disposed of. No costs.
