2. Recording the submissions made by the learned counsel for

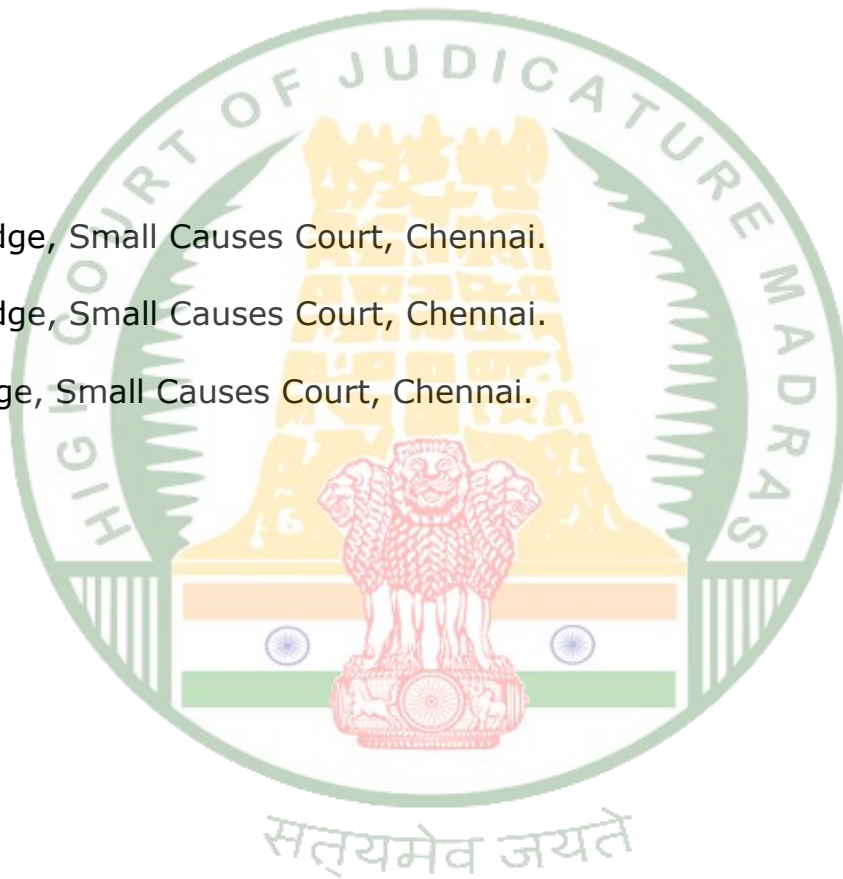
the petitioners as well as the memo, these Civil Revision Petitions are dismissed as withdrawn. No costs.

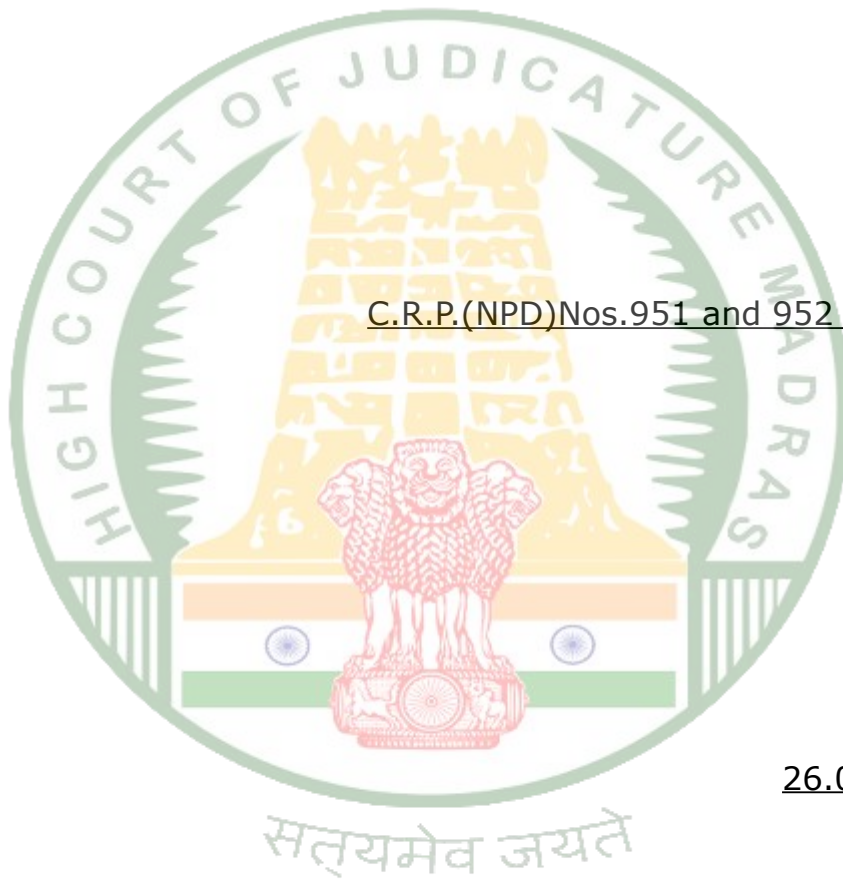
