This Court, at this stage, is not expressing any view on the claim made by the petitioners, as it is for the third respondent to consider and decide the same. Thus, this writ petition is disposed of, only with a direction to the third respondent to consider the representations of the petitioners dated 07.08.2017 and pass orders on the same on merits and in accordance with law, after giving due opportunity of hearing to the petitioners as well as the rival claimants, if any. Such exercise shall be done by the third respondent within a period of twelve weeks from the date of receipt of a copy of this order. No costs.

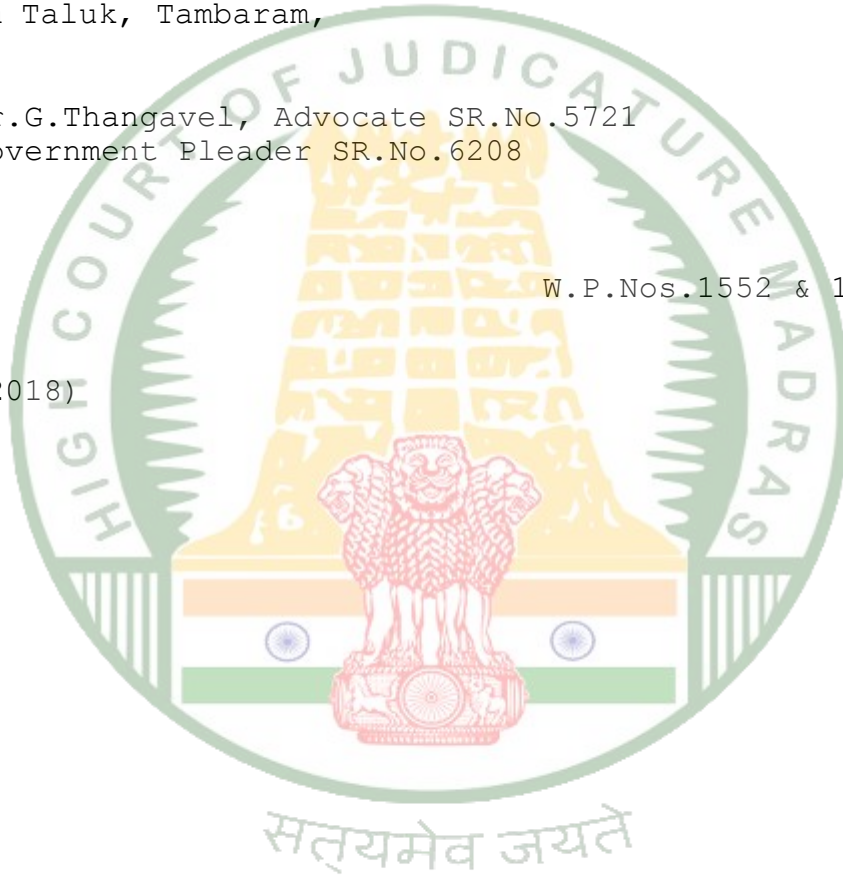
