ORDER

The Special Court, Coimbatore shall complete the trial in C.C.No.84 to 89 and 100 of 1998, within a period of three months and report compliance to this Court. No Costs. Consequently, connected miscellaneous petition is closed.

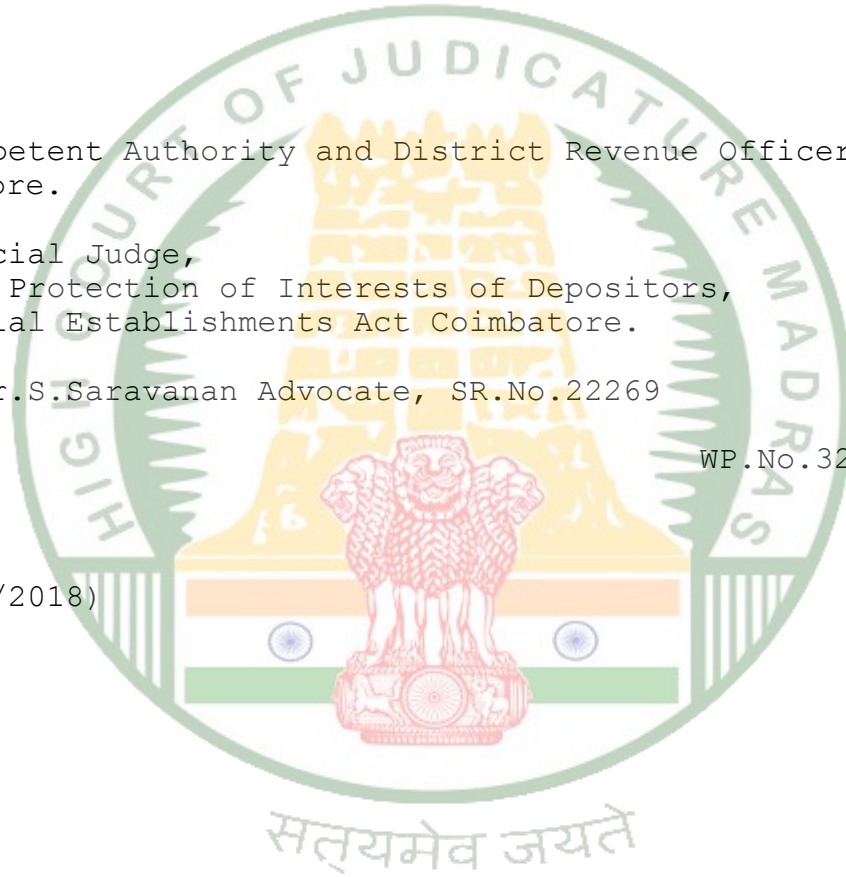
