Order : These petitions coming on for orders upon perusing the petitions and the respective affidavits filed in support thereof and upon hearing the arguments of M/S.P.ULAGANATHAN, Advocate for the petitioner in both the petitions and of M/s.S.THAMIZHARASI, Advocate on behalf of the Respondents in both the petitions the court made the following order:-

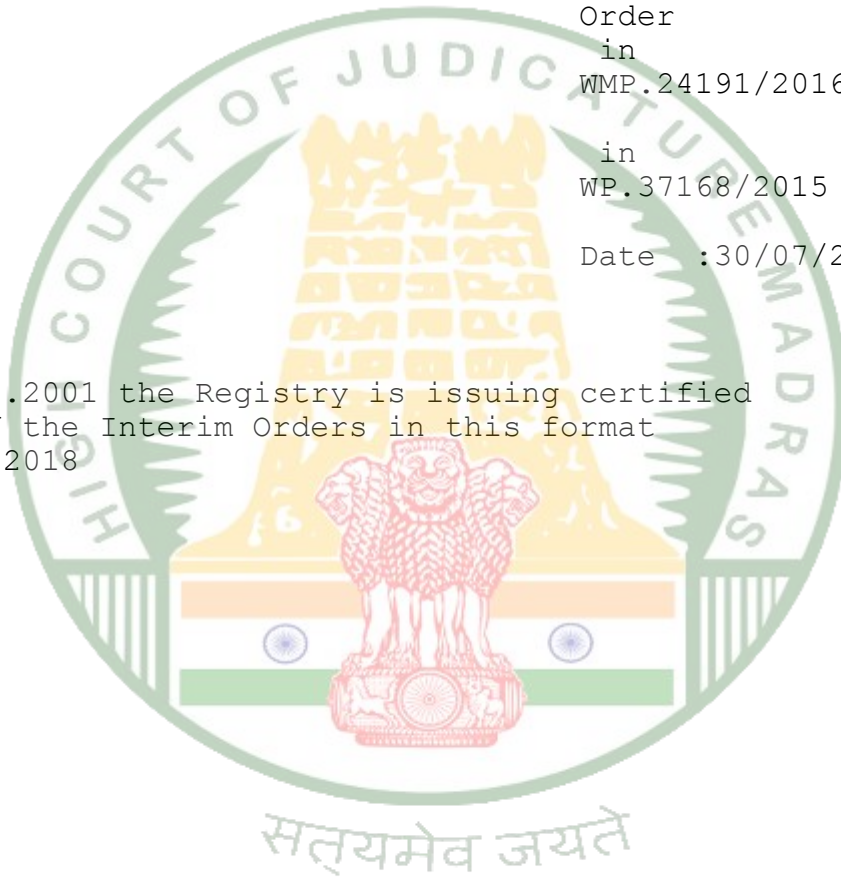
