Prayer in W.P.No.34382 of 2014: Writ Petition filed under Article 226 of the Constitution of India praying to issue a writ or order or direction, particularly in the nature of Writ of Mandamus, directing the respondent to order for re-enquiry as prayed for by the petitioner in his objection and explanation dated 2.5.2014 and 20.10.2014 submitted against the Enquiry Report and the 2nd show Cause notice respectively to prove and establish before the Enquiry Officer about his permanent inability, incapacity and immobility to resume his duty as evidenced by the medical treatment records and that his absence was purely on medical reasons.

Prayer in W.P.No.34383 of 2014: Writ Petition filed under Article 226 of the Constitution of India praying to issue a writ or order or direction, particularly in the nature of Writ of Certiorarified Mandamus, calling for the records connected with the order of the 2nd respondent dated 25.6.2014 passes in

Proceedings No.E4/29656/ TNSTC (Salem) /2014 quash the same and also direct the respondents to reconsider the claim of the petitioner for VRS specifically on the strength of Rule 2(A) of the VRS scheme following the recent Division Bench judgment of the Honourable High Court or alternatively to grant the permanent invalid benefits as per clause 19(a) of the TNSTC Employees pension Fund Trust.
