This Criminal Original Petition has been filed under Section 482 of Criminal Procedure Code, to direct the learned Principal District and Sessions Judge, Krishnagiri, to consider the bail application to be filed by the petitioners in Crime No.82 of 2018 on the file of the Inspector of Police, Berigai Police Station, Krishnagiri District on the same day.

In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioners are directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Principal District and Sessions Judge, Krishnagiri, is directed to consider the bail application filed by the petitioners in connection with Crime No.82 of 2018, on merits and in accordance with law, after issuing notice to the defacto complainant/victim under Section 15(A) of the SC/ST Act.

4. With the above direction, this Criminal Original Petition is disposed of.
