The Deputy Commissioner of Police, Pulianthope, is directed to make available sufficient strength of police to the Inspector of Police, Sembium Police Station, for giving protection for conducting auction, pursuant to the directions of this Court in O.A.No.907 of 2014 in C.S.No.730 of 2014.
