(iii) Grant an interim stay against the 2nd respondents impugned web side of circular No.1 dated 31.05.2018 and web side of circular No. 2 in proceeding Na.Ka.No.007708/D1/2018 dated 01.06.2018 (in WMP.No.16776/2018);

(iv) Direct the respondents not to promote to the post of headmasters in the Middle School in Kalaiyarkovil Union and Devakottai Union Sivagangai district, (in WMP.No.16777/2018) pending disposal of the above WP.Nos.14207 to 14208/2018 respectively.
