Petition under Article 226 of the Constitution of India, praying for the issue of a Writ of Mandamus, directing the respondents herein to pass orders on the representation of the petitioner dated 02.07.2018, thereby the respondents to grant permission and protection for conducting cultural programme on 11.07.2018, night between 8.00 p.m. to 11.00 p.m., at near Sri Mariamman Temple, Keezh Colony, Periyankuppam Village and post, Ambur Taluk, Vellore District.

ORDER

The petitioner seeks a direction to the respondents to grant permission to conduct the cultural programme in the event of Sri Mariamman Temple festival at Keezh Colony, Periyankuppam Village and Post, Ambur Taluk, Vellore District on 11.07.2018 between 8.00 p.m., and 11.00 p.m., by considering his representation dated 02.07.2018.

2. The learned counsel appearing for the petitioner submitted that the petitioner is a resident of Periyankuppam village and also claims to be a member of Vizha Committee. Since the committee has been conducting the cultural programme as a part of temple festival every year in a peaceful manner without any untoward incident in the past, he has submitted a representation to the respondents on 02.07.2018 seeking permission to conduct the cultural programme on 11.07.2018. As

the said representation has not been considered by the respondents so far, the petitioner is before this Court.

3. The learned Government Advocate appearing for the respondents, on instructions, would submit that the permission sought for by the petitioner may be granted with appropriate stringent conditions for maintaining law and order and also to avoid any untoward incident during the performance of such programme.

4. In view of the submission made by the learned Government Advocate for the respondents, this writ petition is disposed of with the following directions:-

(a) The cultural programme in connection with the Sri Mariamman Temple festival at Keezh Colony, Periyankuppam Village and post, Ambur Taluk, Vellore District be held on 11.07.2018 between 07.00 p.m., and 10.30 p.m.

(b) There should not be any kind of obscene dance or vulgar dialogues during the performance, by anyone of the participants.

(c) Double meaning songs should not be played as it may spoil the minds of students and the youths.

(d) No dance or songs, touching upon any political party or religion, community or caste be played.

(e) No flex boards in support of any political party or religious leader, be erected.

(f) The function should not affect either religious or communal harmony and shall be conducted without any discrimination based on caste.

(g) If there is any violation of any one of the conditions imposed, the concerned Police Officer is at liberty to take necessary action, as per law and stop such performance.

(h) Similarly, the Police is empowered to stop the cultural programme, if it exceeds beyond the permitted time.

(i) The participants of the programme shall not intake any kind of toxic substance or liquor during the programme.

(j) If there is any untoward incident taking place, the village people and the organizers of the programme be made responsible for the same; and

(k) The second respondent is directed to issue necessary permission incorporating the above conditions. No costs.
