Khwaja Nazir Ahmed [AIR 1945 PC 18], a direction as prayed for by the petitioner cannot be granted.

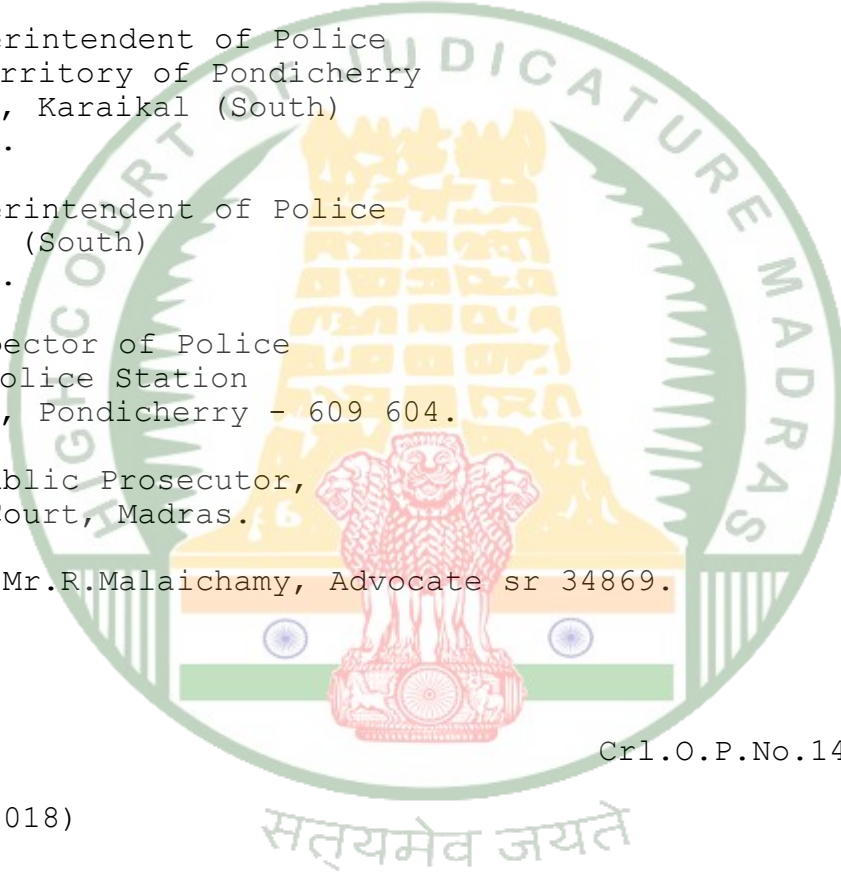
