Prayer: This Writ petition has been filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, calling for the records of the first respondent in RE.D1/RP No.1/07 (L.Ref) dated 10.01.2007 in favour of the respondents 3 and 4 herein in respect of the land in S.F.No.31/1(Part) of an extent of 3 Ac, Dry in Chinna Allerahally village, Bochampally Taluk, Krishnagiri District, and to quash the same and consequently direct the 2nd respondent to consider the representation dated 03.04.2008 of the petitioner herein in respect of the above said lands based on the Revenue records produced before the authorities.

ORDER
