Considering the fact that there are arguable points in the revision and taking into consideration, the facts and circumstances of the case and this Court is inclined to suspend the sentence imposed on the petitioner/accused.

2. The sentence of the imprisonment imposed on the petitioner shall stand suspended and she shall be released on bail on his executing a bond for a sum of Rs.10,000/- with two sureties each for a likesum to the satisfaction of the learned Sessions (Fast Track Mahila) Judge, Namakkal and after his release, **[*] petitioner is directed deposit for a sum of Rs.5,000/- to the credit of Spl.C.C.No.32 of 2016 on the file of the learned Sessions (Fast Track Mahila) Judge, Namakkal on or before 27.07.2018** from the date of his release and further, he shall report before the learned Sessions (Fast Track Mahila) Court, on the **first working day of every month at 10.30 a.m.**
