3.Learned Government Advocate [Crl. Side] submitted that on the complaint given by one Ranganayagi and five others against the petitioners, petition enquiry is pending in C.No.16313/DSP/ALGSC/KPM/2018.

4.In such view of the matter, the petitioners are directed to cooperate with the police for enquiry and at the time of conducting enquiry, they shall not be harassed. During the course of enquiry, if any cognizable offence is made out, the respondent police is free to register an FIR and this order shall not be a shield for the petitioners against arrest.
