Petition for relaxation of the bail condition imposed in Crl.M.P.No.7455 of 2018 in Crl.O.P.No.11155 of 2018 dated 06.06.2018.

2. This court, while granting bail to the petitioner, imposed a condition that the petitioner shall report before the respondent police first and third Saturday of every month at 10.30.a.m., until further orders. The present petition has been filed for relaxation of the said condition.

3. Heard both sides.

4. The condition imposed on the petitioner in Crl.M.P.No.7455 of 2018 in Crl.O.P.No.11155 of 2018 dated 06.06.2018 is modified to the effect that the petitioner is directed to report before the respondent police once in a month, i.e., **first day of every month at 10.30.a.m. until further orders.**
