This court, while granting bail to the petitioner, imposed a condition that the petitioner shall stay at Tirunelveli and report before the Tirunelveli Town police Station daily at 10.30.a.m. and 5.30.p.m, until further orders. The present petition has been filed for relaxation of the said condition.

3. Heard both sides.

4. The condition imposed on the petitioner in Crl.M.P.Nos.8673 and 8674 of 2018 in Crl.O.P.Nos.15885 & 15886 of 2018 dated 28.04.2018 is modified to the effect that the petitioner is directed to report before the respondent police **daily at 10.30.a.m. until further orders.**
