The petitioner has come up with the present writ petition, challenging the impugned communication dated 17.06.2013 issued by the fifth respondent, whereby, the petitioner was expelled from the institution for non-payment of the arrears of tuition fees. 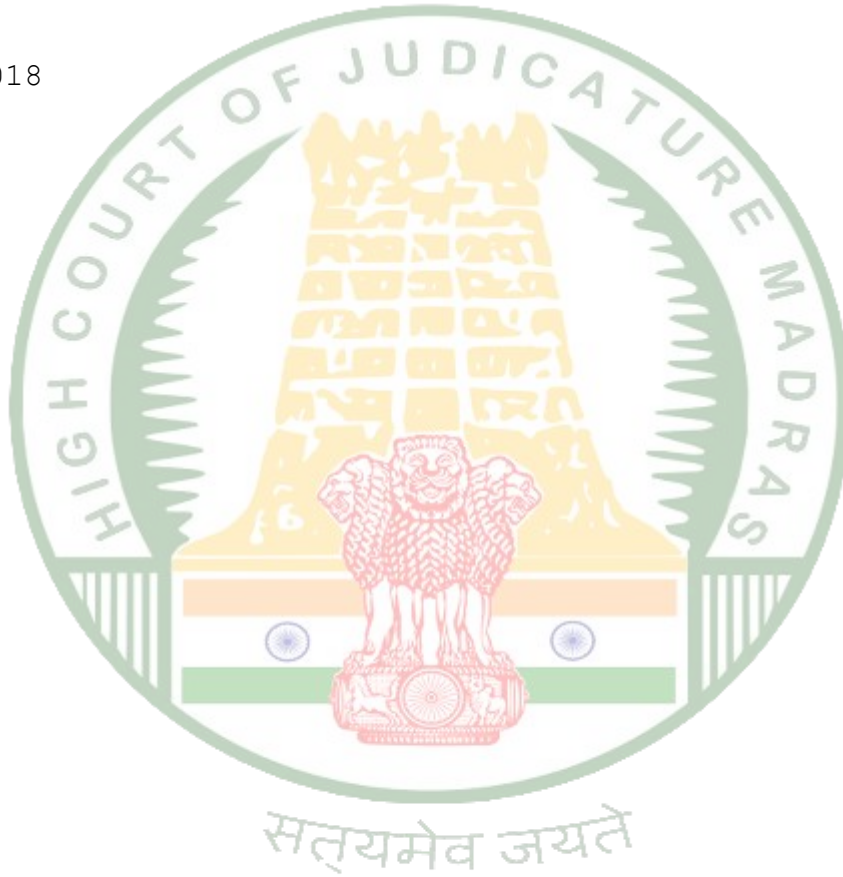
