The learned Government Advocate, by placing reliance on the Government Order in G.O.Ns.No.165 School Education 3(1) Department dated 15.10.2014, fairly submits that nothing survives for adjudication in the present writ appeal, in view of the subsequent decision taken by the Government, whereby and whereunder, Government indicated that the two years Diploma in Teacher Training, obtained prior to 1987 after passing 10th Standard, shall be considered as equivalent to +2(Higher Secondary).

2. In view of the Government Order referred to above, nothing survives for adjudication in this writ appeal.

3. The writ appeal is disposed of with the above observation. No costs. Consequently, connected CMP is closed.

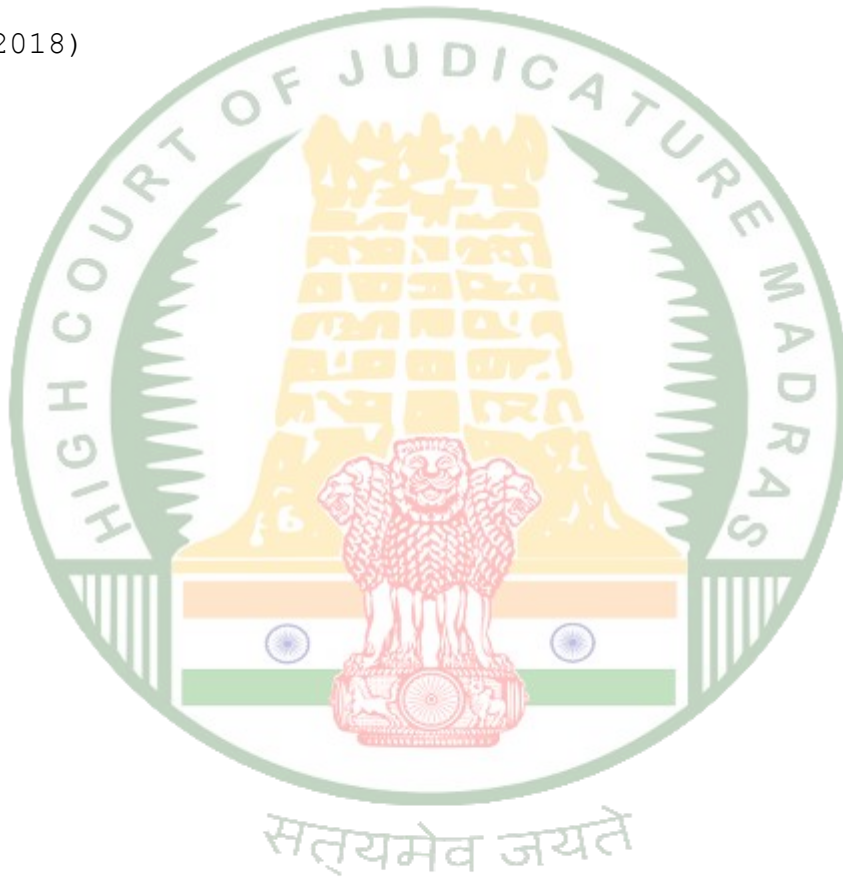
