Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus to call for the records of the first respondent herein relating to his order dated 04.01.2007 made in his proceedings K.Dis.No.53163/F4/96 and quash the same and directing the respondents to rectify the pay anomaly by refixing petitioner's pay on par with the pay of petitioner's junior Tmt.M. Kowsalya as on 02.07.2002 with eligibility for arrears.

ORDER

The petitioner has filed this writ petition challenging the impugned order was passed in proceedings K.Dis.No.53163/F4/96 dated 04.01.2007 by the first respondent and directing the respondents to rectify the pay anomaly by re-fixing the petitioner's pay on par with the pay of
