Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus, calling for the records made in No.Va.Pa.7/2008/Pi.1 dated 27.07.2010 on the file of the 2nd respondent herein and quash the same and further direct the respondents herein to re-determine the compensation for the lands situated in Town Survey Nos.1584, 1585, 1583, 1581, 1588/1, 1588/2, 1589/3, 1587 and 1588 - Well along with all state set in Vellore Municipal limits of Vellore, Vellore District under Section 28-A of the Land Acquisition Act 1894.
