4. Accordingly, this Writ Petition is disposed of with the above direction. No costs.

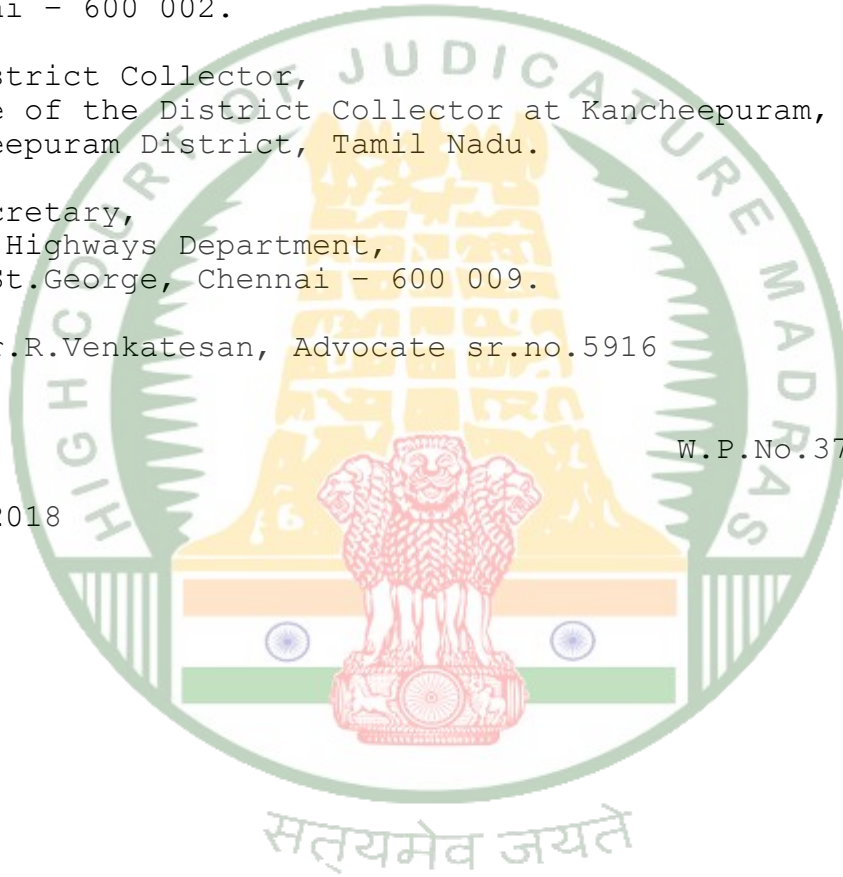
