ORDER

In this case, the petitioner owned separate parcel of lands in Survey Nos. 1570/6 & Survey No.1570/8 at Sriperumbudur village Taluk, Kancheepuram District, were acquired by the Authorities under the provisions of Tamil Nadu Highways Act, 2001 and no award was passed yet.

2. Mr. M. Karthikeyan, the learned Additional Government Pleader, on instructions, assisted by the Special Tahsildar submitted that an award would be passed in terms of Central Act of 30 of 2013.

3. The statement of the learned Additional Government Pleader is hereby recorded. The respondents are directed to award compensation to the petitioner in terms of the Central Act 30 of 2013 and fifth respondent is directed to issue Notices for enquiry at the respective address of the petitioner given in the Writ Petition before passing the award. The fifth respondent is further directed to pass an interim award in this matter within three months from the date of receipt of a copy of this order.

4. Accordingly, this Writ Petition is disposed of with the above direction. No costs.

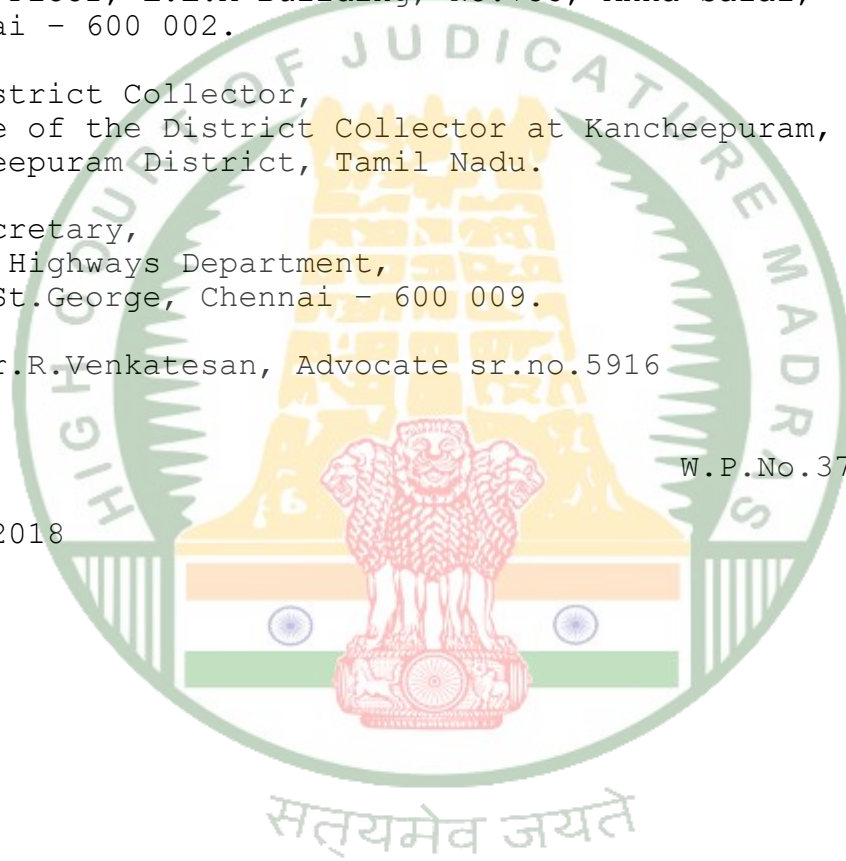
