Petition filed under Article 226 of the Constitution of India to issue a Writ of Declaration declaring that the action of the respondents in returning/rejecting the petitioner claim for reimbursement on the ground of delay as per letter No.57995/pay/99-1 dated 10.10.99 as illegal arbitrary unjust and unreasonable and consequently direct the respondents to pay her a sum of Rs.1,00,000/- towards medical reimbursement together with interest at the rate of 12% per annum award costs.

ORDER

Petitioner has made an application claiming the medical benefits before the respondents and the same has been rejected on the ground that the said application was filed beyond 60 days from the date of discharge from the hospital.
