3. It is represented by Mr.A.N.Thambidurai, learned Special Government Pleader appearing for Respondents 1 to 4 that the encroachment put up by the 4th Respondent has been removed in its entirety and the Petitioner can have free ingress and egress to the Pathway.

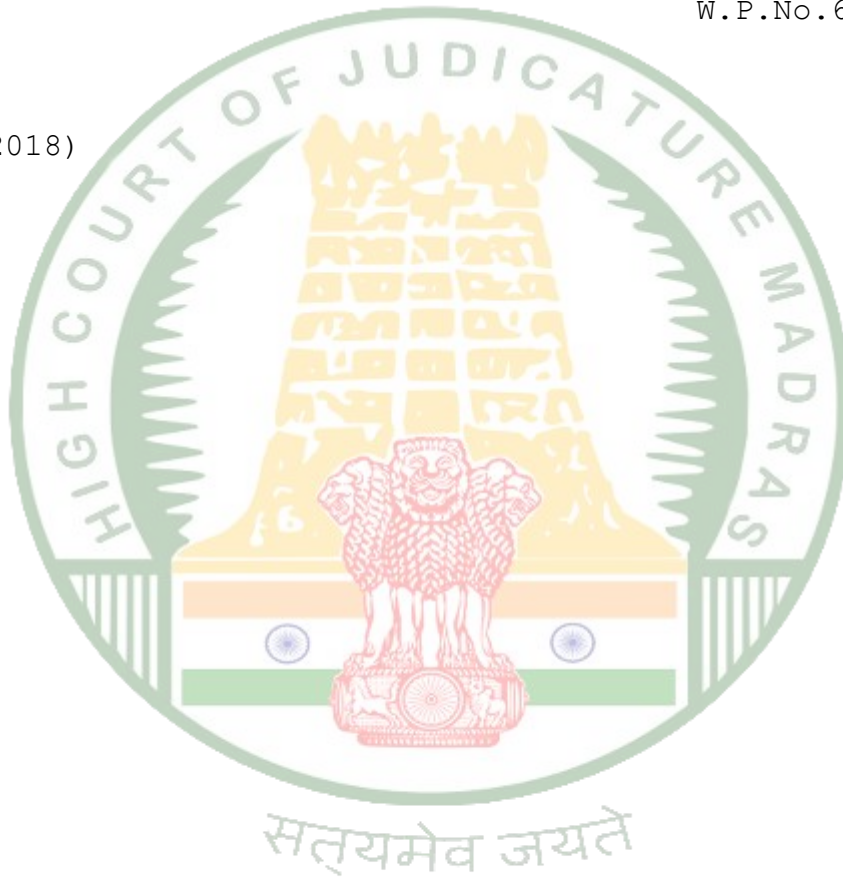
