TERMS OF SETTLEMENT

Both sides present. A joint memo of compromise duly signed by the parties and their advocates has been filed.

2. As per the terms of the compromise, the first respondent agrees to forgo 75% of the backwages and receive 25% of the same amounting to Rs.3,54,476/-. The petitioner also agrees to re-instatement of the first respondent with continuity of service besides agreeing to pay PF contribution to the PF Trust towards

non-employment period from the date of dismissal to the date of re-instatement of the first respondent.

3. On the above terms of compromise, the Writ Petition stands disposed of as settled. Joint Memo shall form part of the record.
