3. The learned Government Advocate (Crl.Side) submitted that the victim boy is aged about only 7 years and the petitioner/accused had sexual misbehavior with the victim boy on various occasions. Therefore, she prayed for dismissal of this miscellaneous petition.

4. Considering the gravity of the offence and the submissions of the Learned Government Advocate (Crl.Side), this Court is not

inclined to grant the relief sought for in this miscellaneous petition and the same is dismissed.
