Writ Petition filed under Article 226 of the Constitution of India, praying to issue a writ of Mandamus directing the respondents 1 to 4 herein to cancel the wrongly issued double entry of UDR patta in Survey No.82/5C3, vide UDR patta No.322 dated 06.07.1990 against the land extent about 1470 sq.ft. in favour of one Late Rajagopal, S/o.Mottaiyan the father of the 6th respondent herein issued by the then Special Thasildhar of (Natham and Tax Scheme) Chengam Taluk, Thiruvannamalai District the 5th respondent herein wrongly taken from the petitioner's land in Survey No.82/5C4, situated at Door No.433, 1st Street, Dr. Ambedkar Nagar, Melpulithiyur Village and Post, Chengam

Taluk, Thiruvannamalai District and measure the land as per the petitioner's sale deed vide document No.464/1959, dated 17.02.1959 on the file of the Sub-Registrar, Chengam on the basis of the petitioner's representation dated 12.05.2016.

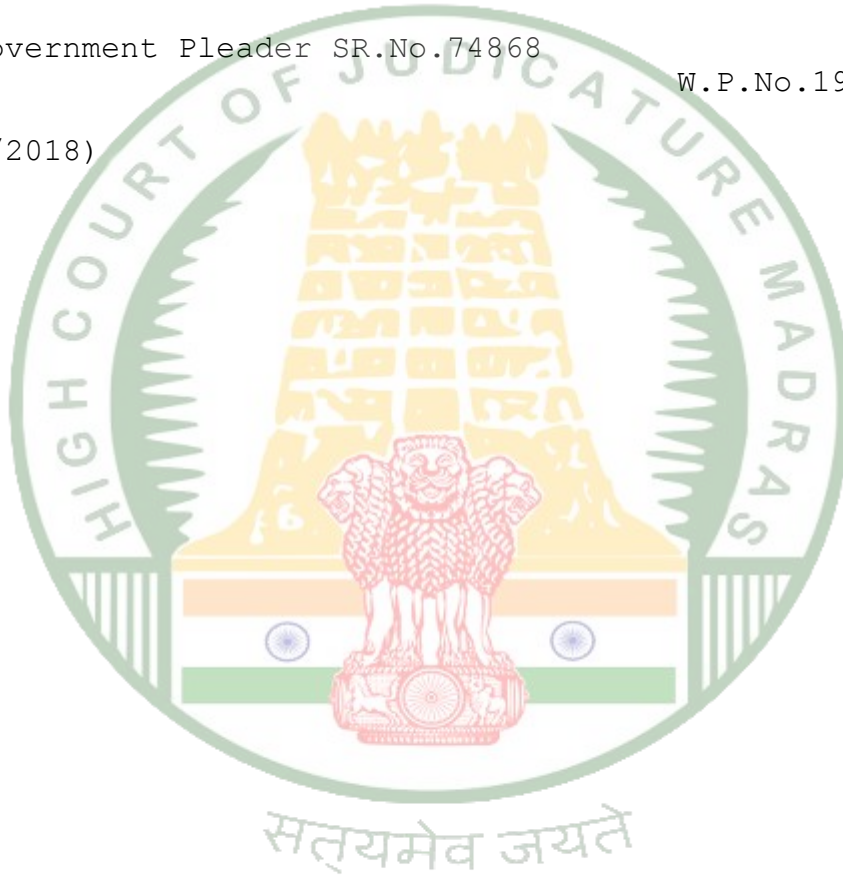
