PRAYER : Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, to call for the records of the 1st respondent relating to the issue of show cause notice in his letter No.6806/Na.Ni.Uo-2-1/1999-13 dated 12.05.2004 and quash the same so far the petitioner is concerned consequently forbear the respondents from taking any further proceedings to withdraw the orders of exemptions to hold the vacant lands and to acquire the same as excess vacant lands measuring to an extent of 24,643 Sq.Mts. in plot No.8 (SP) comprised in old survey Nos.418 pt., 24 pt., 19 pt., 17 pt., 422 pt., 423 pt., 421 pt., 418 pt., 424

pt., 436 pt., 455 pt., and 420 pt., of Ambattur Village, New Survey Nos. 418, 422, 423, 421, 418, 424, 420, 24, 412, 425, 426, 427, 428, 25, 29 & 30 in Ambattur Village and Survey Numbers 24, 25, 29 & 30 in Mannur Village invoking the provisions of Section 3(1) (b) of the Tamil Nadu Urban Land (Ceiling and Regulation) Repeal Act 20 of 1999.
