Earlier, this Court has passed an order on 25.06.2018 in Crl.M.P.No.11593 of 2017, imposing a condition for grant of bail by directing the petitioner to appear before the Trial Court weekly twice, viz., on the first and last working days of every week at 10.30 a.m.

2. The learned Government Advocate (Crl.side) appearing for the respondent would submit that the condition imposed by this Court, has been duly complied with by the petitioner herein till 05.11.2018.

3. Under such circumstances, the petitioner is before this Court seeking relaxation of the condition imposed by this Court vide order dated 25.06.2018.

4. Considering the fact that the petitioner is a student of the Polytechnic College and he has been duly complying with the condition imposed by this Court till recently, the condition as imposed on the petitioner shall stand modified as under.

5. The petitioner shall appear before the Trial Court on the first working day of every calendar month henceforth. This condition shall continue until further orders from this Court.
