3.According to the learned counsel for the petitioner, the petitioner has submitted a representation dated 07.08.2018 alleging the illegal action taken against the fourth and the sixth respondent in demolishing his house, but, the same is yet to be disposed of by the first respondent. Hence, the petitioner is before this Court.

4. Heard Mr.V.Shanmuga Sundar, learned Special Government Pleader on behalf of respondents 1 to 6.

Considering the facts and circumstances of the case and the submissions made on either side, this Court, without expressing any opinion on the merits of the representation, directs the first respondent to consider the petitioner's representation dated 07.08.2018 and pass appropriate orders, on merits and in accordance with law, after issuing notice to the petitioner and respondents 7 to 9 herein and also affording due opportunity of hearing to the petitioner, respondents 7 to 9 herein as well as any of the interested parties, within a period of six weeks from the date of receipt of a copy of this order.

6.With the above directions, this writ petition stands disposed of. No costs.
