This writ petition has been filed seeking a direction to the respondents to consider the petitioner's representation dated 18.08.2018 and pass orders.

2. The grievance of the petitioner is that he is residing in Lakkapuram Village, Modakkurichi Block, Erode District and a sewage canal is running along with the road in front of the petitioner's building. Now, the sewage water drainage has been blocked and over flowing. Hence, he made a representation to the authorities to clean the sewage. But, so far no action has been taken.
