3. Since the order of this Court dated 20.04.2017 in W.P.No.3869 of 2005 has been stayed by a Division Bench of this Court, the contempt petition arising out of the <https://hcservices.ecourts.gov.in/hcservices/> cannot be entertained at this stage. Therefore, this Contempt Petition is closed for the time being with

the liberty to the petitioner to agitate the issue in the manner known to law after the out come of the decision in the Writ Appeal, if the need arises.
